- installing bleachers between 8 & 9 and 10 & 11 and removing large rocks
- installing new shade covers on courts 5, 2 & 3, 6 & 7
- installation of new scoreboards and trash receptacles

- increasing LOGO Building hours and responsibilities
- installing rubber mats between 6 & 7
- implementing Club Rating system
- forming the Bucket Brigade

Chris reported that

- most of the dryness on the courts is almost gone;
- courts are maintained daily;
- Har Tru replacement begins sometime after Thanksgiving, and
- the CA purchased a new roller, so both the north side and the south side has a roller now.
